DENIAL OF TRAFFIC CITATION

REQUIREMENTS FOR SCHOOL ELECTION

- 1) **Must** be able to complete an approved driver improvement school within the State of Florida
- 2) **Must** sign a sworn statement that you have not elected school within the past 12 months and have not elected more than 5 times in a lifetime.
- 3) **Must** pay the required penalty and costs for the ticket. **See below for information on total amount due for election of driver school on all violations**
